WHEREAS it is expedient to amend the Assam Assam Act, (Temporarily Settled Districts) Tenancy Act, III of 1935. 1935, in the manner hereinafter appearing; AND WHEREAS the Governor of Assam has assumed to himself under the Proclamation dated the 25th December 1941 issued by him under 26 Geo. 5, section 93 of the Government of India Act, Ch. 2. 1935, all powers vested by or under the said Act in the Provincial Legislature; Now, therefore, in exercise of the said powers, the Governor of Assam is pleased to make the following Act:-Short title, (Temporarily Settled Districts) Tenancy (Amendcommence- ment) Act, 1942. ment. (2) It shall come into force at once. (3) It shall have the like extent as the Assam Act HII of 1935. (Temporarily Settled Districts) Tenancy Act, 1935, hereinafter referred to as the said Act. Amendment 2. In the heading of Chapter IX of the said of heading Act, for the words "PRIVILEGED Raiyats IX of AND OCCUPANCY Raiyats" the word Assam Act "TENANTS" shall be substituted. 1935. 3. In sub-section (1) of section 79 of the said of section 79 Act for the words "privileged raiyats and occuof Assam pancy raiyats" the words "all or any class or classes of tenants" shall be substituted. 1935. Amendment 4. In section 80 of the said Actof section 80 of Assam Act III of (i) for clause (a) the following shall be sub-1935. stituted, namely-"(a) the name of each tenant"; [Price 4 annas or 5.]

- (ii) (1) for the word "raixat" in clause (b) the word "tenant" shall be substituted;
 - (2) for the word "raiyats" in clause (c) the word "tenants" shall be substituted;
 - (3) for the word "raiyat's" in clause (d) the word "tenant's" shall be substituted.

Amendment 5. In sub-sections (1) and (3) of section 84 of of section the said Act, for the words "privileged raiyats and occupancy raiyats" the words "and tenants" shall be substituted.

Amendment 6. In section 85 of the said Act for the words of section "privileged raiyats and occupancy raiyats" the 85 of Assam words "tenants of any class or classes" shall be 1935.

Amendment of section 107 of Assam Act III of 1935.

- 7. In section 107 of the said Act-
 - (i) for the words "privileged raiyats or occupancy raiyats" in sub section (1) the words "all or any class or classes of tenants" shall be substituted;
 - (ii) for the word "raiyats" in sub-sections (1) and (3) the word "tenants" shall be substituted;
- (iii) for the words "privileged raiyat or occupancy raiyat" in sub-section (8) the words "tenant of any class or classes" shall be substituted.
