ASSAM ACT VII OF 1959

THE ASSAM APPROPRIATION (No.III) ACT, 1959

(As passed by the Assembly)

[Published in the *Assam Gazette*, dated the 13th May 1959]

A
Act

to provide for the authorisation of appropriation of moneys out of the Consolidated Fund of the State to meet the amounts spent on certain services during the financial year ended on the 31st day of March, 1955 in excess of the amount authorised or granted for the said services.

It is hereby enacted in the Tenth Year of the Republic of India as follows :—

1. Short title and commencement.—This Act may be called the Assam Appropriation (No.III) Act, 1959.

2. Issue of Rs.22,92,147 from and out of the Consolidated Fund of the State of Assam for the financial year 1954-55.—From and out of the Consolidated Fund of the State of Assam, the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of twenty-two lakhs, ninety-two thousand, one hundred and forty-seven rupees shall be deemed to have been paid and applied to meet the amounts spent for defraying the charges in respect of the services specified in column (2) of the Schedule during the financial year ended on the 31st day of March, 1955 in excess of the amounts authorised or granted for those services for that year.

3. Appropriation.—The sums deemed to have been paid and applied from and out of the Consolidated Fund of the State of Assam under this Act shall be appropriated and shall be deemed to have been appropriated,

for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 1955.
