further to amend the Assam Land (Requisition and Acquisition) Act, 1948.

Whereas it is expedient further to amend the Assam Assam Act Land (Requisition and Acquisition) Act, 1948, hereinafter XXV 1948. Preamble. called the principal Act, in the manner hereinafter appear-

It is hereby enacted as follows:—

Short title. extent and commence-

1. (1) This Act may be called the Assam Land (Requisition and Acquisition) (Amendment) Act, 1949.

(2) It shall have the like extent as the principal Act.

(3) It shall come into force at once.

2. In sub-section (2) of section 1 of the principal Act, for the words " one year from the date of its enforcement 1(2), Assam the words "five years" shall be substituted, and the words beginning with "provided that the Government may" and ending with " and to a total of two years as it may deem fit " shall be omitted.

3. In section 2 of the principal Act after clause (d) the Amendment of section 2, following new clause shall be added, namely:-Act

"(e) 'displaced person' means -

(i) any person, who on account of the setting up of the two Dominions of India and Pakistan or on account of civil disturbances or the fear of such disturbances in any area now forming part of Pakistan has been compelled to leave his place of residence in such area after the 1st day of March 1947 and who has subsequently been residing in India and is in distress,

(ii) a person who has been displaced due to various acquisition proceedings relating to land in Assam since

4. In section 3 of the principal Act in the 6th line of of section sub-section (1) after the word "drainage" the following 3(1), Assam shall be added, namely—Act XXV of

"or for providing land individually or in groups to landless, flood-affected or displaced persons, or to a society registered under the Indian Co-operative Societies Act, Act II of 1912 (with such statutory re-enactment or modification thereof as shall from time to time be made) or a company incorporated under the Indian Companies Act, 1913, Act VII of formed for the benefit and rehabilitation of landless flood. formed for the benefit and rehabilitation of landless, floodaffected or displaced persons";

"(c) the manner and the conditions and terms on which land will be settled or disposed of by Government".
