An Act to provide for the constitution of a Revenue Tribunal.

WHEREAS it is expedient to provide for the Preamble. constitution of a Revenue Tribunal for the Province of Assam by an Act of the Provincial Legislature;

It is hereby enacted as follows:-

CHAPTER I

PRELIMINARY

1. (1) This Act may be called the Assam Short title, extent and Revenue Tribunal Act, 1946. commence-(2) It extends to the whole of the Province of

- (b) Of the Members, one shall be a nonofficial who has been for not less than ten years a pleader, advocate, or barrister, or who has for at least ten years held a judicial office in British India not inferior to that of a subordinate Judge, and the other shall be the Director of Land Records, Assam.
- (c) No person shall be appointed to or retained in the post of President or non official Member after he has attained the age of sixty years.

Filling vacancies.

(4) Any vacancy in the office of the President or the non-official Member of the Tribunal shall be filled up in such manner as may be prescribed.

Salary officers.

(5) The President and the non-official Member shall be paid such salary as may be prescribed.

Termination. of terms of officers.

4. Notwithstanding anything contained in the preceding section, the Provincial Government may in its discretion terminate at any time the term of office of the President or the non-official Member of the Tribunal, if, in its opinion, such President or Member is unable or unfit to continue to perform the duties of his office.

Powers and functions of the Tribunal.

- 5. (1) The Tribunal shall exercise such jurisdiction to entertain appeals and revise decisions in revenue cases as was vested in the Provincial Government immediately before the 1st day of April 1937 under any law for the time being in
- (2) In particular and without prejudice to the generality of the foregoing provision the Tribunal shall have jurisdiction to entertain appeals and revise decisions:-
 - (a) in all revenue cases arising under the provisions of the enactments specified in the schedule, in which such jurisdiction was vested in the Provincial Government immediately before the 1st day of April 1937, and
 - (b) in all cases specified in section 9.
- (3) Save as expressly provided in any enactment for the time being in force the Provincial Government may, by notification in the official Gazette, direct by general or special order that the Tribunal shall also have jurisdiction to entertain and decide appeals and applications for revision in any case in which the Provincial Government has or may have jurisdiction to entertain and decide such appeals and applica-

> Provided further that no such decision or order shall be varied or revised unless notice has been given to the parties interested to appear and an opportunity has been given to be heard in support of such order.
