ASSAM ACT NO. XLIV OF 2023

(Received the assent of the Governor on 31st July, 2023)

THE ASSAM APPROPRIATION (No. XIV) ACT, 2023

AN ACT

to provide for the authorisation and appropriation of moneys out of the Consolidated Fund of the State of Assam to meet the amounts spent on certain services during the financial year, 2016-17 in excess of the amount authorised or granted for the said services.

Be it enacted by the Assam Legislative Assembly in the Seventy-fourth Year of the Republic of India as follows:

Short Title

1. This Act may be called the Assam Appropriation (No.XIV) Act, 2023.

Issue of Rs.1345,44,35,431.00 from and out of the Consolidated Fund of the State of Assam for the financial year, 2016-17

2. From and out of the Consolidated Fund of the State of Assam the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of Rupees Thirteen Hundred Forty Eight Crore Forty Four Lakh Thirty Five Thousand Four Hundred Thirty One shall be deemed to have been paid and applied to meet the amounts spent for defraying the charges in respect of the services specified in column (2) of the Schedule during the financial year 2016-17 in excess of the amount authorised or granted for those services for the year.

Appropriation

3. The sums deemed to have been paid and applied from and out of the Consolidated Fund of the State of Assam shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty First day of March, 2017.
