THE MISING AUTONOMOUS COUNCIL (AMENDMENT) ACT, 1997

further to amend the Mising Autonomous Council Act, 1995.

Whereas it is expedient further to amend the Mising Assam Preamble. Autonomous Council Act, 1995, hereinafter referred to as the Act, XXVI principal Act, in the manner hereinafter appearing; of 1995

> It is hereby enacted in the Forty-eighth Year of the Republic of India as follows:-

Short title, extent and commencement.

- 1. (1) This Act may be called The Mising Autonomous Council (Amendment) Act, 1997.
- (2) It shall have the like extent as the principal Act.
 - (3) It shall come into force at once.

Amendment of section 80

- 2. In the principal Act, the existing section 80 shall be substituted by the following, namely: --
- "Transitional 80. The Government shall, as soon as possible, take steps for the constitution of an Interim General Council by provision. nomination and to nominate the Executive Council there-from to perform in addition, the functions of the Village Councils till the General Council is constituted under this Act.
